We are here for you!

How can I or my children obtain benefits for education and integration (BuT)?

Benefits are usually billed directly to the service provider. The lump sum for school supplies (lump sum per school semester) and travel costs are paid out directly to you.

Benefit now!

The following groups are entitled to receive benefits:

- Recipients of SGB II-Benefits (Jobcenter Lippe),
- Recipients of Housing Benefits and Children's allowance (Kreis Lippe),
- Recipients of SGB XII-Benefits or according to the Asylum Seeker's Benefits Act (AsylbLG)

Benefits for education can be provided to students until the age of 25 if they attend a general or vocational school and do not receive any apprentice salary.

Benefits for integration into social and cultural activities can only be provided to children and teenagers who are under the age of 18.

Which benefits are available?



Does the nursery/school organize any field trip for one day or school trip for several days?

- ✓ Events of the Institution (e.g. KiTa /School)
- ✓ Participation of the entire group
- ✓ Actual costs (without pocket money) can be covered



Does your child need a school bag or writing materials?

- ✓ For the purchase of textbooks, exercise books, writing and drawing materials, electronic calculator, etc.
- ✓ School supply package for 2022
 - 1 August: 104 euros
 - 1 February: 52 euros



Do you need travel costs reimbursement for your child to attend school? (bus ticket)

- ✓ We refund your child's bus ticket to attend the nearest school (primary school, secondary school) – unless such costs are already covered by the school authority.



Would you like your child to receive private lessons or coaching?

- ✓ Existing learning deficits can be remediated to be able to achieve the set learning objective
- ✓ School-based offerings are insufficient (to be confirmed by the school)



Does your child require lunch?

- ✓ At school
- ✓ At the nanny's house
- ✓ At the day-care centre
- ✓ At the child's daycare facility
- ✓ Joint group lunch



Does your child want to pursue any hobbies?

- ✓ For children and teenagers under the age of 18
- ✓ For club, cultural and holiday activities (e.g. music, sports, arts, games and socializing events, leisure time, theatre camp, scouts, etc.)
- ✓ 15 euros per month (max. 180 euros in case of savings)
